
We recommend screwing Knobs (19) into second hole from the top in Left and Right Arms (3 and 4). This will give you a standard 30" high table top. Every hole raises or lowers the table by 1.75".






## Fully tighten all bolts from steps 1-4.










#### STEP 7


Locate the pilot holes (see arrows) in the Shelf (6) and slide it into the rails, with the laminated side up, then attach with two Screws (24). Leave the Screws slightly loose.



Unfold Drawers (15) and insert the flat base.










#### STEP 11

Lift the Top, slide Metal Tray (32) over edge of table, and secure using Allen Screws (25) (do not overtighten). Insert Cup (33) and Art Tray (34) into slots.



Leave the Phillips Screws (24) slightly loose so the Pencil Ledge (16) can slide freely.





Note the curve on the Legs - see arrows.
